Dear Maritime Interests,

Please remember that the **Great South Channel Seasonal Management Area (SMA) comes into effect APRIL 1**. This means that all three northeast SMAs will be in effect (Off Race Point through April 30, Cape Cod Bay through May 15, Great South Channel through July 31), as well as all of the mid-Atlantic SMAs through April 30 and the southeast SMA through April 15. Vessels 65 ft. and greater must slow to 10 knots or less when transiting through these areas. Compliance guides for the right whale ship strike reduction rule are available. ## **Legislative Update**

The legislative session began January 7 and has been in full swing ever since. There are numerous bills this session that will have an impact on boating safety, should they pass. The DEP submitted a bill this year entitled An Act Concerning Marine Dealers, Marine Surveyors and Yacht Dealers. It is mostly a matter of equity and a need to update law to reflect new technologies. Yacht brokers often do not have offices, yet run legitimate businesses to sell boats. Bill No. 824, will allow yacht brokers and marine surveyors to have marine dealer registration numbers. Marine surveyors have never been able to apply for marine registration numbers, that are similar to auto dealer plates. The bill has received a Joint Favorable out of the Environment Committee and will proceed to the Legislative Commissioner's Office (LCO), Office of Fiscal Analysis (OFA) and Office of Legislative Research (OLR) for review and anlaysis before it is sent to the floor. For your information any bill that did not make it out of the Environment Committee by March 20 is essentially dead. It is expected to pass, unless it is not called for a vote.....which can and does happen. Joint Favorable means both Republicans and Democrats approved it.

The Governor submitted Bill, No. 832, *An Act Concerning Boating Safety,* which will create the penalty of manslaughter in the second degree for the intoxicated boater who causes the death of another. This bill was passed out of the Environment Committee and then went to

the Judiciary Committee, where it was passed out of the committee with substitute language. It will now be reviewed by LCO, OFA and OLR. It is expected to pass.

House Bill 6160, entitled An Act Concerning Reciprocal and Concurrent Sanctions for Operating a Motor Vehicle or a Vessel While under the Influence of Intoxicating Liquor or any Drug will be an incredibly powerful deterrent to operating under the influence. This bill ties Driving Under the Influence with Boating Under the Influence. If arrested for DUI, your boating certificate would concurrently be suspended and for BUI, your driver's license would be suspended. Ten other states have similar connections. This has been JFed out of Judiciary and is under LCO/OFA/OLR Review.

HB 5467, An Act Concerning the Speed of Vessels in the Mystic River, Williams Cove, Beebe Cove, West Cove and Palmer Cove seeks to expand the speed zones already in place on the Mystic River. DEP is working with the crafters of the bill to determine the best vehicle for this, as it may be by regulation. If that is the case a public hearing will be held and all users of the River will be invited to provide comments.

I will keep you apprised of how these bills are doing. Please keep in mind these changes that went into effect October 2008.

- Children 12 and under must wear life jackets when above deck and underway, this is up from 11 years and under.
- A child under 16 can operate a vessel other than Personal Watercraft (ie. JetSki) without a certificate if under direct supervision of a person at least 18 or older who has had a certificate for at least 2 years.
- Only boats 40 feet and up need a bell.
