begun its northbound declination. Each passing day brings a little more daylight and a little less darkness. I'm a lot more conscious of the apparent movement of the sun this year, having just completed the United States Power Squadron JN course. I must admit, I was hesitant in signing up for the JN course. When would I ever have the need for offshore navigation techniques? What was the practical use for a coastal sailor? This course (as with all advanced USPS courses) requires time and commitment but was certainly worth the effort. Boat shows are how folks in New England celebrate their passion in the middle of winter.

On another matter, the results of the USPS national planning committee survey have been released. As you may recall many of you received an e-mail questionnaire asking for your opinion about USPS. The results are not surprising. An overwhelmingly significant number of our members indicated that education was the primary reason for joining USPS and for staying with USPS. The member benefits like insurance discounts are not a significant factor in people joining or staying with the squadrons, according to the survey. In terms of problems that we need to overcome our members cited the organizational hierarchy and paramilitary approach. Also, the survey indicates that a national marketing plan is needed. #### Rules to Live By By Jack Kurrus , SN



In this issue we will study the only Rule, Rule 19 in Section/Subpart III. You will recall Sub- section I specified Conduct of Vessels in any Condition of Visibility, and Section II specified Conduct of Vessels in Sight of One Another. It is interesting to note that only one Rules is devoted exclusively to conditions of restricted visibility while there are eight Rules for much better conditions. The Inland and International Rule 19 are exactly the same.

#### Rules 19 Conduct of Vessels in Restricted Visibility

- (a) This Rule applies to vessels not in sight of one another when navigating in or near an area of restricted visibility.
- (b)Every vessel shall proceed at a safe speed adapted to the prevailing circumstances and conditions of restricted visibility. A power driven vessel shall have her engines ready to maneuver.
- (c)Every vessel shall have due regard to the prevailing circumstances and conditions of restricted visibility when complying with Rules 4 through 10.
- (d)A vessel which detects by radar alone the presence of another vessel shall determine if a close quarters situation is developing or risk of collision exists. If so she shall take avoiding action in ample time, provided that such action consists of an alteration of course, so far as possible the following shall be avoided:
- (i) an alteration of course to port for a vessel forward of the beam, other than for a vessel being overtaken; and
- (ii) an alteration of course toward a vessel abeam or abaft the beam.

(e)Except where it has been determined that a risk of collision does not exist, every vessel which hears apparently forward of her beam the fog signal of another vessel, or which cannot avoid a close quarters situation with another vessel forward of her beam, shall reduce her speed to the minimum at which she can be kept on course. She shall if necessary take all way off and, in any event, navigate with extreme caution until danger of collision is over.

Note: For many years Safe Speed in limited visibility was considered to be nothing in excess of seven(7)knots. This value was determined from Maritime Law courts that never found for any vessel that was making speed, in excess of seven knots, in limited visibility. In the past several years however some cases have approved slightly higher speeds for vessels involved in collisions. The courts have found slower less maneuverable vessels must use slower speeds than higher speed craft that are more maneuverable. Thus, the old half-the-distance of visibility rule, which focused on vessels stopping to avoid collision, is too narrow a measure of safe speed, particularly since Rule 8(c) now favors course changes to avoid collisions because they tend to be more apparent to the other vessel than stopping.
