Lots of things happening in NLPS!



The New London Power Squadron recently applied for a grant offered by BoatU.S. Foundation. BoatU.S. Foundation is a national 501(c)(3) nonprofit organization dedicated to promoting safe and environmentally sensitive boating. This year they made a total of \$50,000 available to small nonprofit organizations. The maximum grant to any one organization is \$4,000. The money must be used on projects that promote the goals established by BoatU.S. Foundation. This year's target goal is to promote the proper use of a PFD when boating.

We applied for just under the maximum, with the money to be used on items to be used this spring when we hold our Safety/VSC days at the marinas. We have proposed to give a free T-Shirt away (yet to be designed) to anyone who promises to wear their PFD while boating. Also in the funding proposal there is money allocated for a new squadron table and floor displays as well as advertising and printing to promote these events. Thanks to Robert Leete, Chris Wick, Eleanor Mariani, and Doreen Sharkey for helping in preparation in the grant request. We should have a decision by mid February.

On another matter, Jack Kurrus, Lea Jewett and I visited the Sea Scout Ship *Dragon* sponsored by the Groton Sub-Vets. We attended one of their regular Monday night meetings where the scouts were learning about magnetic versus true north and how variation changes as you move about the globe. There were about twelve scouts present, both boys and girls, and six adult volunteers. It was heartwarming to see these great young people engaged in constructive learning while still having a great time. The skipper and I agreed to keep each other informed of our activities and some of the scouts will be taking our courses.

Is it too early to start planning our summer cruises? Not according to the Meriden Power Squadron. They are planning their 2008 summer cruise and have invited New London and other members of the District to attend. Last year's cruise was to Cuttyhunk and Martha's Vineyard.

This year, they plan to coordinate with the District rendezvous that will be going to Greenport and then on to Montauk and Block Island. I can

Directions:

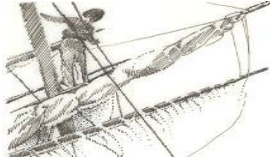
From I-95 Exit 74, follow CT Route 161 south towards Niantic.

Go 0.8 mi., passing Three Belles Marina and Smith Cove on your right; turn right onto North Rd, marked by two stone pillars with carved arrow heads on top.

Turn right at first stop sign onto West Rd. Go one block, tennis courts on left, to stop sign at Round Rock Rd.

November 1982 *The November 1982 issue of the Yardarm was chock-a-block with fun stories.*

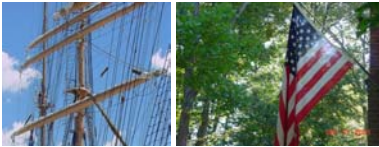

Rules to Live By

In last month issue I reviewed Rule 2 Responsibility which described in detail who is responsible for making the Rules of the Road work. This month we will look at Rule 3 General Definitions which provides definitions to terms used throughout the Rules. Less frequently used terms are defined where they appear, See Rule 12(B), 13(B), 14(B), 21 and 32.

It is interesting to note that Rule 3 of the Inland Rules of the Road mirror almost exactly the International Rules of the Road except when discussing the Western River Rules or special situation on the Great Lakes. Exception will be listed at the end of the International Rules summary

Rule 3 Definitions

- a. The word Vessel: The word “**vessel**” includes every description of watercraft, including non-displacement craft and seaplanes, used or capable of being used as a means of transportation on water.
- b. The term “**power driven vessel**” means any vessel propelled by machinery.
- c. The term “**sailing vessel**” means any vessel under sail provided that propelling machinery if fitted, is not being used.
- d. The term “**vessel engaged in fishing**” means any vessel fishing with nets, lines, trawls or other fishing apparatus which restrict maneuverability, but does not include a vessel fishing with trolling lines or other fishing apparatus which does not restrict maneuverability.
- e. The word “**seaplane**” includes any aircraft designed to maneuver on the water.
- f. The term “**vessel not under command**” means that through exceptional some circumstance is unable maneuver as required by these Rules and is therefore unable to keep out of the way of another vessel.
- g. The term “**restricted in her ability to maneuver**” means a vessel which from the nature of her work is restricted in her ability to maneuver as required by these Rules and therefore unable to keep of the way of another vessel.
- h. The term “**vessel constrained by her draft**” means a power-driven vessel which because of her draft in relation to the available depth of water is severely restricted in her ability to deviate from the course she is following.
- i. The word “**underway**” means that a vessel is not at anchor, or made fast to the shore, or aground.
- j. The words “**length and breadth**” of a vessel means her length overall and the greatest breadth.
- k. Vessels shall be deemed to be insight of one another only when one can be observed visually from the other.
- l. The term “**restricted visibility**” means any condition in which visibility is restricted by the fog, mist, falling snow, heavy rainstorms, sandstorms or any other similar causes.

Rule 3 Inland Definition (exceptions)

- a. “**Western Rivers**” means the Mississippi River, its tributaries, South Pass, Southwest Pass to the navigational demarcation lines dividing the high seas from harbors, rivers and other inland waters of the USA.
- b. “**Great Lakes**” means the Great Lakes and their connecting waters.
- c. “**Secretary**” means the Secretary of the Department in which the Coast Guard is operating.
- d. “**Inland Waters**” means the navigable waters of the United States shoreward of the navigational States and the water of the Great Lakes on the United States side of the International Boundary demarcation lines dividing the high seas from harbors, rivers, and other inland waters of the United States.

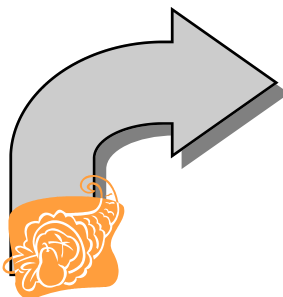
